Ohio Administrative Code Rule 3745-1-51 Wetland narrative criteria. Effective: July 30, 2018

[Comment: To the extent the director has specificauthority under Chapter 6111. of the Revised Code, including sections 6111.03and 6111.041 of the Revised Code, the criteria specified in this rule areapplicable to the maintenance or rehabilitation (enhancement) of wetlandfunctions. Such authority includes the issuance of certifications under section401 of the Clean Water Act, 33 U.S.C. section 1341, and Chapter 3745-32 of theAdministrative Code, the issuance of NPDES permits under section 402 of theClean Water Act, 33 U.S.C. section 1342, and Chapter 3745-33 of theAdministrative Code, the issuance of permits and plan approvals underChapter 3745-42 of the Administrative Code and sections 6111.44 and 6111.45 of the Revised Code.]

In addition to the criteria listed in rule3745-1-04 of the Administrative Code, to every extent practicable and possibleas determined by the director, and except as authorized in accordance with rule3745-1-54 of the Administrative Code, the following narrative criteria shallapply to wetlands.

(A) The hydrology necessary to support the biological and physical characteristics naturally present in wetlands shall be protected to prevent significant adverse impacts on any of the following:

(1) Water currents, erosion or sedimentation patterns.

- (2) Natural water temperature variations.
- (3) Chemical, nutrient and dissolved oxygen regimes of the wetland.
- (4) The movement of aquatic fauna.

(5) The pH of the wetland.

(6) Water levels or elevations, including those resulting from ground water recharge and discharge.

(7) The biological integrity of natural floral and faunal communities.

(B) Water quality necessary to support existing habitats, and the populations of wetland flora and fauna shall be protected to prevent significant adverse impacts on any of the following:

(1) Food supplies for fish and wildlife.

- (2) Reproductive and nursery areas.
- (3) Dispersal corridors, as that term is defined in rule 3745-1-50 of the Administrative Code.
- (4) Biodiversity.
- (5) Maturity level of woody vegetation.

(6) Water quality shall be protected to prevent conditions conducive to the establishment or proliferation of nuisance organisms, as that term is defined in rule 3745-1-50 of the Administrative Code.

(C) Conditions shall not occur that will have a significant adverse impact on the ability of the wetland to be used for wetland-dependent recreational opportunities in or on the water.
