SERIES PURPOSE:

The purpose of the CCC project crew leader occupation is to provide gainful employment for people between the ages of 18-24, to instruct them in outdoor education, natural resources/conservation work, basic construction principles & safety procedures & provide counseling to them on life skills, career counseling & guidance.

Glossary: Wherever the term listed below appears in this document it is to be interpreted as follows:

Life skills, career counseling & guidance: Training, educating & coaching others (1) in the basic skills needed to be productive in the work place & in life (e.g., cleanliness/hygiene, appropriate appearance, willingness to learn & to accommodate what is required), (2) to resolve conflict in an acceptable manner, (3) to get up & go to work, report to work on time & maintain consistent good attendance, (4) to maintain balanced nutrition, health & safety awareness, (5) to develop healthy leisure time activity, (6) to respect oneself, others & property, (7) to live as good stewards of the earth/environment, (8) to work cooperatively as members of a team, (9) to be free of drugs & alcohol, and (10) to set career &/or educational goals & outline realistic steps to achieve them.

<u>JOB DUTIES IN ORDER OF IMPORTANCE</u>: (These duties are illustrative only. Incumbents may perform some or all of these duties or other job-related duties as assigned.)

Selects & coordinates work projects for civilian conservation project crews, determines manpower, equipment & transportation needs, assigns CCC project crew leaders to projects, monitors & inspects projects during & after completion, recommends approval of completed projects or determines need for additional work, oversees work crews during disaster relief & emergency situations & supervises CCC project crew leaders.

Maintains project records reflecting resources used, project costs, manpower, training provided/needed, work accomplishments & requests for assistance; prepares annual reports; reviews reports submitted by staff; researches & gathers information on proposed projects; maintains inventory of equipment, purchases & issues equipment; assists central office staff with long term project planning; interviews & selects corpsmembers.

MAJOR WORKER CHARACTERISTICS:

Knowledge of supervisory principles/techniques; basic construction principles & safety; natural resources or conservation; civilian conservation corps rules & procedures*; interviewing*. Skill in use & operation of tools & equipment used in natural resources/conservation activities & basic construction. Ability to define problems, collect data, establish facts & draw valid conclusions; plan & coordinate conservation projects; establish friendly atmosphere as supervisor; interview prospective corpsmembers & determine their suitability for program.
