**SERIES PURPOSE:**

The purpose of the criminal intelligence analyst occupation is to research, analyze, coordinate and generate reports regarding criminal intelligence information for the purpose of assisting law enforcement agencies.

At the first level, incumbents collect, organize and analyze data for criminal intelligence analytical functions.

At the second level, incumbents review and analyze problems and develop research tools and/or means used in analyzing criminal intelligence information.

**JOB DUTIES IN ORDER OF IMPORTANCE: (These duties are illustrative only. Incumbents may perform some or all of these duties or other job-related duties as assigned.)**

Collects, researches, analyzes, coordinates & organizes data regarding criminal intelligence information (e.g., determine patterns, events, identities & activities of criminal groups) & prepares analytical reports, charts & analysis (e.g., link analysis; time &/or commodity flow; telephone, cellular telephone & pager tolls; other computerized charts) for review & verification by higher-level criminal intelligence analysts or administrators.

Assists administrators & higher-level criminal intelligence analysts in achieving unit goals & objectives (e.g., coordinates exchange of interstate information pertaining to criminal activity & movement; develops rapport with user agencies; contacts various law enforcement agency personnel & legal personnel to provide information relative to criminal activity, movement &/or other criminal intelligence information); testifies in court; assists higher-level criminal intelligence analysts as assigned; recommends policy & procedure changes (e.g., unit goals & objectives; bureau directives; unit procedures) to supervisor; ensures compliance with applicable federal statutes, Ohio revised codes & Ohio attorney general's office bureau of criminal investigation directives; assists bureau agents & outside law enforcement agencies during investigations of various criminal cases (e.g., theft in office; illegal gambling; fraudulent court filings; fraudulent property liens; strategic planning for extremist group rallies).

**MAJOR WORKER CHARACTERISTICS:**

Knowledge of criminal justice or related field\*; operational, mathematical, analytical &/or statistical research techniques used in problem solving or decision making. Skill in use of personal computer &/or video display terminal\*. Ability to define problems, collect data, establishes facts & draw valid conclusions; use research methods in gathering data; prepare meaningful, concise & accurate reports; handle sensitive inquiries from & contacts with other law enforcement agencies & general public.

**JOB DUTIES IN ORDER OF IMPORTANCE: (These duties are illustrative only. Incumbents may perform some or all of these duties or other job-related duties as assigned.)**

Independently reviews & analyzes problems related to sophisticated &/or complex criminal activity (e.g., serial homicide; serial rape; gambling ring; narcotics; common law movement; domestic terrorism; organized crime; investigations involving multiple charges, several years worth of records, multiple bank accounts, multiple jurisdictions, or public official corruption &/or obstruction of justice) from other bureau units & user agency personnel & develops proper research tools & methods (e.g., link analysis; time &/or commodity flow; telephone, cellular telephone & pager tolls; other computerized charts) & intelligence request forms to appropriately accommodate intelligence information, develops & analyzes informational databases, spreadsheets & reports allowing information to be easily exchanged & understood, prepares case reports & charts for user agencies &/or court systems & testifies in court & maintains case files.

Collect, researches & analyzes intelligence information & other resources to determine patterns, trends & movements of organized crime groups, terrorists &/or professional criminals to aid law enforcement agencies with investigations & makes presentations to case agents &/or law enforcement agencies; coordinates research activities with other departmental units &/or outside agencies; may act as lead worker (i.e., provides work direction & training) over lower level criminal intelligence analysts; recommends policy & procedural changes (e.g., unit goals & objectives; bureau directives; unit operating procedures) to supervisor or higher-level authority; ensures compliance with applicable federal statutes, Ohio revised codes & Ohio attorney's office bureau of criminal investigation directives; assists in reviewing & recommending software & hardware equipment.

Serves as resource person & technical advisor (e.g., responds to requests for information; represents agency in meetings) in area of criminal intelligence; schedules, coordinates &/or conducts classes, seminars & conferences; coordinates interstate & intrastate information; maintains association with & facilitates exchange of information between federal, state & local law enforcement agencies for disposition of criminal activity &/or intelligence information.
