Rule 4141-37-09 Failure to comply with determination on surety bond or deposit.

Effective: [September 1, 2026](#)

A reimbursing employer's election to make payments in lieu of contributions shall be terminated if such employer fails to comply with any determination of the director increasing the bonding amount or requiring restoration of the unobligated security of an account.

The termination of a reimbursing employer's election will be effective beginning the first day of the calendar quarter following the employer's failure to comply with determinations provided for in this rule.
