Rule 4167-3-03 Amending of existing standards.

Effective: April 9, 2026

(A) The administrator of workers' compensation, with the advice and consent of the bureau of workers' compensation board of directors, has the authority to amend Ohio employment risk reduction standards.

(B) The Ohio employment risk reduction standards are amended as referenced by:
